**PREAMBLE**

Preambular paragraph 3

Amend to read as follows:

(3) *Recalling* the ~~final declarations~~ **outcomes** of specialised United Nations conferences, in particular the International Conference on Financing for Development, held in Monterrey, Mexico in 2002; the World Summit on Sustainable Development, held in Johannesburg, South Africa in 2002; and the Third United Nations Conference on Least Developed Countries, held in Brussels, Belgium in 2001,
