VACANCIES TO BE FILLED DURING THE 115th ASSEMBLY

EXECUTIVE COMMITTEE

On 18 October 2006, the Governing Council will be required to elect **two members** to replace Mr. H. Al Hadi (Libyan Arab Jamahiriya) and Ms. A. Vadai (Hungary), whose terms of office expire at the time of the 179th session of the Governing Council.

Candidatures from the corresponding geopolitical groups - the African Group and the Twelve Plus Group - accompanied by a signed covering letter and a brief curriculum vitae, may be submitted up to Tuesday, 17 October by 2.30 p.m.

SUBSIDIARY BODIES OF THE GOVERNING COUNCIL OF THE INTER-PARLIAMENTARY UNION

Committee on the Human Rights of Parliamentarians (permanent)

On 18 October 2006, the Governing Council will be required to elect:

- (i) **One titular member** to fill the post left vacant by Mr. F. Margáin (Mexico), who is no longer a member of parliament;
- (ii) **One titular member** to replace Mrs. V. Nedvedova (Czech Republic), whose term of office has expired; and
- (iii) **Two substitute members** to replace Ms. S. Carstairs (Canada) and Ms. Z. Benarous (Algeria), who were elected titular members at the time of the 178th session of the Governing Council.

Candidatures from the corresponding geopolitical groups, accompanied by a signed covering letter and a brief curriculum vitae, may be submitted up to Tuesday, 17 October by 2.30 p.m.

To date the following candidature has been received:

- Mr. N. Cherginets (Belarus): candidature submitted by the Parliament of Belarus.

Committee on Middle East Questions (ad hoc)

On 18 October 2006, the Governing Council will be required to elect:

- (i) **One titular member** to replace Mrs. M. Bergé-Lavigne (France), whose term of office expires at the time of the 179th session of the Governing Council; and
- (ii) **One substitute member** to fill the post left vacant by Ms. P. Torsney (Canada), who is no longer a member of parliament, and which was not filled during the last Governing Council session in Nairobi.

Candidatures, accompanied by a signed covering letter and a brief curriculum vitae, may be submitted up to Tuesday, 17 October by 2.30 p.m.

APPOINTMENT OF TWO INTERNAL AUDITORS FOR THE 2007 ACCOUNTS

On 18 October, the Governing Council will appoint **two Internal Auditors** for the 2007 fiscal year. They will report in Spring 2008. Parliamentarians interested in submitting their candidature for this position should preferably have prior experience either in a parliamentary finance or audit committee.

Candidatures, accompanied by a signed covering letter and a brief curriculum vitae, may be submitted up to Tuesday, 17 October by 2.30 p.m.

Third Standing Committee (Democracy and Human Rights)

The Third Standing Committee, at its last sitting on Wednesday, 18 October 2006, will be called upon to elect a **substitute Vice-President** from the Twelve Plus Group. The former incumbent Mr. H.S. Järrel (Sweden) is no longer a member of parliament.
