PREAMBLE

Preambular paragraph 1

Amend to read as follows:

Operative paragraph 18

Amend to read as follows:

18. *Calls on parliaments to exercise oversight over the working of law enforcement and security agencies so as to enforce their accountability in ~~protecting~~ **respecting** fundamental individual freedoms while performing their public duties;*

(Germany)

Operative paragraph 19

Amend to read as follows:

19. *Emphasizes the need for training of security forces **and law enforcement actors** in order to sensitize them to human rights while dealing with terrorism and related activities;*

(Indonesia)

Amend to read as follows:

19. ***Recognizes the need to counsel perpetrators of oppression, discrimination and other related acts against ethnic and religious minorities in order to raise their awareness of human rights and the need to counsel victims of oppression and discrimination in order to build their capacity to overcome their predicament and** emphasizes the need for training of security forces in order to sensitize them to human rights while dealing with terrorism and related activities;*

(Republic of Korea)

Amend operative paragraph 19 and move it to the place of operative paragraph 9ter:

19. *Emphasizes the need for training of security forces **and intelligence agencies** in order to sensitize them to human rights while dealing with terrorism and related activities;*

New operative paragraph 19bis

Add a new paragraph after operative paragraph 19 to read as follows:

19bis. Underscores that in a constitutional State, the security organs must be considered as the principal guardians of citizens' rights;

(Morocco)

Add a new paragraph, after operative paragraph 19, to read as follows:

19bis. Urges national parliaments to pass legislation that will require law enforcement agents to deliver terror suspects to the judicial authorities immediately upon arrest to avoid them being taken anywhere else for interrogation or further detention;

Operative paragraph 20

Move operative paragraph 20 to the place of operative paragraph 9quater.

(South Africa)

Amend to read as follows:

20. *Recommends* that national governments work towards greater regional **and global** cooperation with regard to implementing anti-terrorism strategies and establishing anti-terrorism centres;

(Venezuela)

Operative paragraph 21

Delete the existing paragraph.

(France)

Move operative paragraph 21 to the place of operative paragraph 9quinquies.

(South Africa)

New operative paragraph 21bis

Add a new paragraph, after operative paragraph 21, to read as follows:

21bis. Underscores the need to distinguish between terrorism and the struggles of peoples to liberate their land and regain their legitimate rights in accordance with international law;

(Algeria)

Operative paragraph 22

Amend to read as follows:

22. *Calls on* all parliaments and *urges* the Inter-Parliamentary Union to develop training programmes designed to build the capacity of parliamentarians in order to address complex issues in an effective manner; **and welcomes the sharing among parliaments of best practices on such initiatives.**

(Japan)

Amend to read as follows:

22. *Calls on* all parliaments and *urges* the Inter-Parliamentary Union to develop training programmes **and to establish national human rights training centres** designed to **raise awareness of human rights and** build the capacity of parliamentarians in order to **help them strike a balance between national security, human security and individual freedoms and to** address complex issues in an effective manner.

(Republic of Korea)

Amend to read as follows:

22. *Calls on* all parliaments and *urges* the Inter-Parliamentary Union to develop training programmes designed to build the capacity of parliamentarians in order to address ~~complex issues~~ **the linkages between national security, human security and individual freedoms** in an effective manner.

(Romania)

New operative paragraphs 22bis, 22ter, 22quater, 22quinquies and 22sexies

Add five new paragraphs after operative paragraph 22 to read as follows:

- 22bis. ***Invites* parliaments and the governments of countries of origin of patented drugs for endemic and life-threatening diseases such as HIV, tuberculosis and malaria, among others, to cancel those patents and allow the free use of such drugs;**

- 22ter. ***Encourages* parliaments to reduce agricultural subsidies in order to foster greater international competition, thereby allowing countries unable to grant subsidies to contribute to such competition;**

- 22quater. ***Requests* the international financial and/or economic institutions, such as the International Monetary Fund and the Inter-American Development Bank, to refrain from advocating recessionary policies;**

- 22quinquies. ***Recommends* that appropriate measures be taken to prevent international tribunals from overstepping their jurisdiction so as to achieve the goals of reducing poverty, preventing recessionary policies and exercising closer parliamentary scrutiny;**

- 22sexies. ***Expresses* its concern at the action of international arbitral tribunals (ICSID) - the offspring of multilateral lending agencies - which have been distorted into instruments for gauging the policies of dominant States;**

New operative paragraphs 22bis and 22ter

Add two new paragraphs after operative paragraph 22 to read as follows:

22bis. *Recommends* that parliaments do not content themselves with framing several laws or adopting international conventions, recommendations and resolutions on human rights and human freedoms only to subsequently put them aside, but that they ensure that governments take the necessary measures for their implementation and execution, in order to prevent all cases of inhuman treatment;

22ter. *Recommends* that the United Nations, and in particular the IPU Committee on United Nations Affairs, cooperate more with the Member Parliaments of the Inter-Parliamentary Union in order to implement all resolutions dealing with human security;

(Morocco)

Add a new paragraph, after operative paragraph 22, to read as follows:

22bis. *Recognizes* the importance of establishing an independent national human rights institution and a National Action Plan for the promotion and protection of human rights in striking a balance between national security, human security and individual freedoms and seeking to complete the realization of democracy and urges parliaments to establish a national human rights institution and enact a law, upon which basic frameworks for national human rights policies can be based;

Add a new paragraph, after operative paragraph 22, to read as follows:

22bis. *Requests* that parliaments guarantee total respect of the principle of non-refoulement established in the framework of international refugee law and international human rights law, while recalling that international refugee law provides for exclusion clauses;
