**COOPERATION AND SHARED RESPONSIBILITY IN THE GLOBAL FIGHT AGAINST

**PREAMBLE**

Preambular paragraph 1

Amend to read as follows:

(1) Cognizant of the fact that while globalization fosters many positive advancements, interdependence between States and the opening **free movement across** of borders, it also facilitates transnational organized crime, in particular **illicit drug trafficking, illegal arms sales, illicit trafficking in firearms, human trafficking in persons, cross-border terrorism and money laundering**, involving an increasing number of stakeholders, actors and agencies and requiring global, regional, subregional and national responses, including the implementation of **related conventions relevant international and domestic legal instruments**,

*(Indonesia)*

Amend to read as follows:

(1) Cognizant of the fact that while globalization fosters many positive advancements, interdependence between States and the opening of borders, **it has, moreover, a negative effect, that of it also facilitating** transnational organized crime, in particular drug trafficking, illegal arms sales, human trafficking, cross-border terrorism and money laundering, involving an increasing number of stakeholders, actors and agencies and requiring global, regional, subregional and national responses, including the implementation of related conventions,

Preambular paragraph 2(bis)

Add a new paragraph after preambular paragraph 2 to read as follows:

New preambular paragraph (5bis)

Add a new paragraph after preambular paragraph 5 to read as follows:

**(5bis) *Also aware that the illicit trade and stockpiling of firearms, especially small and light weapons, are sources of aggravation of conflicts, causing severe social, humanitarian and economic damage to the people of the world, who see as seriously compromised their right to life and peace and the benefits of sustainable development,***

New preambular paragraphs (5bis) and (5ter)

Add two new paragraphs after preambular paragraph 5 to read as follows:

**(5bis) *Aware that the issue of refugees is closely related to that of trafficking in persons, and that this issue needs to be addressed collectively by the international community,***

**(5ter) *Cognizant of the fact that not all countries that welcome illegal refugees have sufficient capacity and economic resources to take care of them,***

**(5ter) *Recalling the United Nations Convention against Transnational Organized Crime and its additional Protocol to Prevent, Suppress and Punish Trafficking in Persons, Especially Women and Children, the first global instrument against transnational organized crime that calls for concerted action at the global level, which is also the first legally binding United Nations instrument in this field,***

Preambular paragraph 6

Amend to read as follows:

(6) *Recognizing* the **direct and indirect** links between **transnational organized crime, such as illicit** drug trafficking, corruption, ~~and other forms of organized crime, including money laundering,~~ trafficking in persons, **illicit** trafficking in firearms, **and** cyber crime, **and** ~~cross-border terrorism, including money laundering in connection with~~ the financing of terrorism,

Operative paragraph 1

Amend to read as follows:

1. *Fully affirms* the strong determination and clear commitment of IPU Member Parliaments to strengthening and harmonizing ~~drug-related~~ laws, regulations and additional measures **on narcotic drugs, psychotropic substances and their precursors in accordance with relevant international legal instruments on drug control**, pursuing strong regional cooperation to combat **illicit** drug trafficking ~~within the framework of international cooperation with international legal instruments on drugs~~ **in accordance with relevant international legal instruments on drug control**, and to enhancing the technical capability of law enforcement and judicial authorities;

New operative paragraph 1

Add a new paragraph before operative paragraph 1, to read as follows:

1. ***Invites IPU Member Parliaments to support efforts aimed at achieving universal adherence to, and full implementation of the UN Convention against Transnational Organized Crime and its Protocols and encourages further steps for the establishment of a monitoring mechanism to review implementation of the Convention;***

2. ***Reaffirms its unwavering determination and commitment to intensify efforts to counter the illicit cultivation, production, manufacture, sale, abuse, transit, trafficking and distribution of narcotic drugs and psychotropic substances, especially heroin, cocaine, **cannabis**, amphetamine-type stimulants (ATS), the diversion of precursor chemicals, misuse of pharmaceutical medicines and preparations as well as drug-related criminal activities, through a balanced, comprehensive and sustainable approach;***
