**PROVIDING A SOUND LEGISLATIVE FRAMEWORK AIMED AT PREVENTING
ELECTORAL VIOLENCE, IMPROVING ELECTION MONITORING AND
ENSURING A SMOOTH TRANSITION OF POWER**

***Amendments to the revised preliminary draft resolution submitted
within the statutory deadline by the delegations of Canada, France, Germany, India,
Indonesia, Italy, Japan, Morocco, Sweden, Venezuela and the Latin American Parliament***

PREAMBLE

Preambular paragraph 1

Amend to read as follows:

(1) *Recalling* the Universal Declaration of Human Rights of 1948, the United Nations International Covenant on Civil and Political Rights, and the African Charter on Human and Peoples' Rights, which, inter alia, provide that every citizen, **regardless of gender, religion, and race** has a right to take part in the conduct of public affairs directly or through chosen representatives, and that the will of the people should be **represented and** expressed through free and fair elections so as to constitute the basis for legitimate and credible authority of government,

(Indonesia)

Amend to read as follows:

(1) *Recalling* the Universal Declaration of Human Rights of 1948, the United Nations International Covenant on Civil and Political Rights, and the African Charter on Human and Peoples' Rights, which, inter alia, provide that every citizen has a right to take part in the conduct of public affairs directly or through chosen representatives **by voting**, and that the will of the people should be expressed through free ~~and fair~~ **universal, secret and direct** elections **in the full exercise of sovereignty** so as to constitute the basis for legitimate and credible authority of government,

(Venezuela)

New preambular paragraph (7bis)

Add a new paragraph after preambular paragraph 7 to read as follows:

(7bis) **Reaffirming that it is up to each State to organize free and fair elections and to guarantee that they are conducted by guarding against disruptive acts of violence, and recalling that States may request necessary assistance from the international community to strengthen their election mechanisms, notably through election observer missions,**

Preambular paragraph 8

Amend to read as follows:

(8) *Underscoring* the crucial role played by national and international election observers and monitors **wherever the law so provides** in encouraging participation and providing an independent assessment of an election and a measure of transparency and accountability to the process,

(India)

(8) *Underscoring* the crucial role played by national and international election observers and monitors in encouraging participation and providing an independent assessment of an election and a measure of transparency and accountability to the process, **without undermining the respective countries' national integrity and sovereignty,**

(8) *Underscoring* the crucial role played by national and international election observers and monitors in encouraging participation and providing an independent assessment of an election and a measure of transparency and accountability to the process, **respecting the principle of sovereignty and relevant national legislation,**

(Latin American Parliament)

Amend to read as follows:

(8) *Underscoring* the crucial role played by national and international election observers **or accompanying electoral** monitors in encouraging participation and providing an independent assessment of an election and a measure of transparency and accountability to the process, **taking into account the principles of sovereignty, territorial integrity and inviolability, self-determination of peoples, non-interference, impartiality, transparency and respect for the rules and electoral authorities of each State,**

(Venezuela)

New preambular paragraphs (10bis) and (10ter)

Add two new paragraphs after preambular paragraph 10 to read as follows:

(10bis) *Underscoring, however, that during the peace-building process, only national political will, expressed at free and regular elections, can lend its full legitimacy to permanent national institutions,*

(10ter) *Stating the need for sustainable financing for newly established or strengthened institutions in situations where countries are emerging from crisis,*

(12) *Acknowledging the 2005 Declaration and Code of Conduct for International Election Observation **wherever the law provides, and** endorsed by a host of organizations, including the United Nations, the International Institute for Democracy and Electoral Assistance (IDEA) and others in addition to the IPU,*

Add a new paragraph after preambular paragraph 13 to read as follows:

(13bis) *Underscoring that the period between elections is critical to maintaining a viable electoral framework that contributes to legitimate electoral outcomes and avoids violence, enabling electoral management bodies, election monitors and civil society groups to plan future elections, train election officials, update voter registries, educate voters, as well as review the electoral machinery and electoral legislation to determine where deficiencies might lie and how to correct them,*

Operative paragraph 1

Amend to read as follows:

1. *Calls upon parliaments, where necessary, to undertake constitutional and legislative reform, building on international obligations and commitments and taking into account local realities, so as to provide a sound legal framework for **transparent**, free and fair elections that includes the adoption of electoral systems that provide for representative and inclusive outcomes, and the smooth transfer of power;*

1. *Calls upon parliaments, where necessary, to undertake constitutional and legislative reform, building on international obligations and commitments and taking into account local realities, so as to provide a sound legal framework for free, **universal**,*

(Venezuela)

New operative paragraph 1bis

Add a new paragraph after paragraph 1 to read as follows:

1bis. Invites all IPU Member Parliaments to elaborate laws that make it mandatory for candidates and political parties to conduct election campaigns in conformity with international standards that guarantee respect for the will of the people;

(Morocco)

Operative paragraph 2

Amend to read as follows:

2. Urges parliaments to conduct such electoral reform through a comprehensive, inclusive and open debate that fosters the broadest possible involvement of all stakeholders, authorities, political parties, ~~media, and civil society organizations~~ **organizations and social movements** in the electoral process;

(Latin American Parliament)

Amend to read as follows:

2. Urges parliaments to conduct such electoral reform through a comprehensive, inclusive and open debate that fosters the broadest possible involvement of all stakeholders, authorities, political parties, media, **and all popular organizations** ~~and civil society organizations~~ in the electoral process;

(Venezuela)

Operative paragraph 4

Amend to read as follows:

4. Encourages national election management bodies to make greater efforts to ensure sustainability and cost-effectiveness, as well as the use of appropriate cutting-edge technologies, in particular information and communication technology, so as to make the electoral process "people-friendly", efficient and safe from malpractice, while ensuring transparency and public confidence;

(Venezuela)

Operative paragraphs 3 and 5

Combine and amend operative paragraphs 3 and 5 into a new paragraph 5 to read as follows:

5. Urges parliaments to enact legislation giving strong regulatory, investigative and prosecutorial powers to **independent and impartial** election management bodies so that they can ~~effectively deal with~~ **safeguard the integrity and transparency of the electoral process by preventing** instances of electoral fraud, intimidation and other improprieties ~~committed in the course of an election~~ **and reporting them to the competent authorities;**

Operative paragraph 5

Amend to read as follows:

5. *Urges* parliaments to enact legislation giving strong regulatory, investigative and prosecutorial powers to **organizations such as** election management bodies so that they can effectively deal with instances of electoral fraud, intimidation and other improprieties committed in the course of an election;

Operative paragraph 7

Amend to read as follows:

7. *Calls upon* parliaments to enact legislation to ensure that political parties and candidates conduct their election campaigns according to prescribed norms, and that the election machinery functions in a non-partisan and professional manner to encourage a level playing field ~~for political contestants~~ as well as a violence-free **electoral and** political environment, including through the application of harsh sanctions against perpetrators of such violence;

(Morocco)

Operative paragraph 8

Amend to read as follows:

8. *Also calls upon* parliaments to consider formulating a ~~model code of conduct~~ **legislative framework** with regard to the funding of political parties and electoral campaigns, as well as to the conduct of the electoral campaign itself, in order to ensure that a ~~climate~~ **conditions** of safety, order and transparency prevails with maximum public participation in the exercise of citizens' right to vote;

Operative paragraph 9

Amend to read as follows:

9. *Urges* all governments to redouble their efforts to ensure active and wider participation of the citizens in elections through an inclusive voter registration process that effectively accommodates both women and men, **the disabled**, national minorities, indigenous people, internally displaced persons and other vulnerable groups;

- 12bis. *Further urges* all parties concerned in situations where countries are emerging from a crisis or from violent community, ethnic or religious tensions, to conclude an inclusive political accord to allow the peaceful conduct of free and fair elections in the framework of institutions that are respectful of minority interests;**

Operative paragraph 13

Amend to read as follows:

13. *Calls upon* parliaments and governments to ensure unrestricted access by election observers and monitors, both national and international, to observe national elections, in keeping with international standards, obligations, commitments and principles **whenever their country makes such a request;**

13. *Calls upon* parliaments and governments to ensure ~~unrestricted~~ access by election observers and monitors, both national and international, **depending on local needs and the provisions of the law,** to observe national elections, in keeping with international standards, obligations, commitments and principles;

New operative paragraph 15bis

Add a new paragraph after paragraph 15, to read as follows:

Invites the United Nations and other international organizations and partners concerned to incorporate in their peace-building strategies from the outset human and financial assistance measures aimed at strengthening or establishing a set of democratic institutions, and in particular a parliament elected through free and regular elections;**

Operative paragraph 16

Amend to read as follows:

16. Urges parliaments in countries with a **recent** history of electoral violence to enact specific legislation to ~~restrict~~ **limit and prohibit** the use of firearms ~~and live ammunition, and guarantee that military and security institutions and agents remain neutral and are not subject to manipulation for electoral purposes~~ **during the electoral process;**

New operative paragraph 16bis

Add a new paragraph after paragraph 16, to read as follows:

- 16bis. Invites parliaments and governments to elaborate strict and stringent laws prohibiting any attempt to destabilize the electoral process and providing for the prosecution of the perpetrators of acts of violence;**

(Morocco)

Operative paragraph 17

Amend to read as follows:

17. Appeals to ~~civil~~ society organizations, media groups, experts, academic institutions, human rights agencies and international organizations to sensitize citizens to their constitutional rights and obligations regarding elections, including through comprehensive civic and voter education programmes;

(Venezuela)

Operative paragraph 19

Combine and amend operative paragraphs 19 and 7 into a new paragraph 1bis to read as follows:

19. Calls upon parliaments to enact appropriate legislation to guarantee the fundamental rights of citizens in the political process, including the right of individuals to cast a secret ballot, the right to open **and multiple sources of** information and free expression, ~~and~~ the right to peaceful public demonstration **as well as freedom of organization for political parties and the freedom for candidates to conduct their election campaigns on an equal footing and in a violence-free political environment;**

20. *Calls upon* Member Parliaments to **ask political parties**, until political violence against women is eliminated and women are empowered both economically and politically, **to consider various approaches to increase the proportion of women candidates for parliamentary elections to at least 30 per cent, by such means as providing incentives, setting numerical targets and introducing quota systems that apportion a certain percentage of candidates to women** ~~at least 30 per cent of parliamentary seats are reserved for women;~~

21. *Urges* parliaments and governments to ensure that electoral laws are stable and predictable by codifying them or enacting them in statute law and by entrenching the basic principles of electoral democracy **and the right to vote and to run for elections** in the national constitution so as to prevent manipulation of election rules by parties in power;
