VACANCIES TO BE FILLED DURING THE 127th ASSEMBLY

EXECUTIVE COMMITTEE

On 24 October 2012, the Governing Council will be required to elect **two members**, as follows:

One vacancy to replace Mr. A. Díaz-Caneja (Mexico), **Latin American Group**

whose term of office expires at the end of the 191st session

of the Governing Council.

Eurasia Group One vacancy to replace Mr. M. Vardanyan (Armenia), who

is no longer a member of parliament and whose Executive

Committee term ends in October 2013.

In accordance with Article 23.6 of the Statutes, if a member of the Executive Committee ceases to be a parliamentarian, the Member of the Union concerned shall appoint a substitute to serve until the next session of the Governing Council, when an election shall be held. If the newly elected member is from a different parliament than the outgoing member, he/she will serve a full term. Otherwise, the new member shall complete the term of office of his/her predecessor (in this case until October 2013).

Candidatures from the corresponding Geopolitical groups, accompanied by a signed covering letter and a brief curriculum vitae (one page maximum), may be submitted up to Tuesday, 23 October 2012, at 9 a.m.

Committee on the Human Rights of Parliamentarians

On 24 October, the Governing Council will be required to elect:

Two substitute members to replace Mr. P. Martin-Lalande (France) and Ms. A. Kairuki (United Republic of Tanzania).

Committee on Middle East Questions

On 24 October, the Governing Council will be required to elect:

Van Miltenburg (Netherlands) who has resigned her post on the Committee, following her election as Speaker of Parliament;
