It is our pleasure to inform you that the IPU Committee on United Nations Affairs will convene during the 129th IPU Assembly from Monday, 7 to Wednesday, 9 October 2013.

2. TIMETABLE

The Committee will meet on Monday, 7 October from 9 a.m. to 1 p.m., when it will consider items 1, 2 and 3 of its agenda, and from 2.30 to 6.30 p.m., when it will deal with items 4 and 5. On Wednesday, 9 October, it will convene from 9 a.m. to 1 p.m. to consider item 6 of the agenda, adopt its report and deal with any other business.

3. PARTICIPATION

All IPU Members, Associate Members and international organizations and other bodies attending the Assembly as observers are invited to participate in the work of the Committee.

As decided by the governing bodies of the IPU at its previous Assembly in Quito (March 2013), the IPU Committee on United Nations Affairs will be transformed into the fourth IPU Standing Committee, and meet on the occasion of each IPU Assembly. In the process, the Committee on UN Affairs will maintain its unique mandate to give direction to the evolving relationship between the United Nations and the IPU and to assist in the elaboration of parliamentary input to major UN processes.

As such, all Member Parliaments are kindly encouraged to plan for members of their delegation to attend the sessions of the Committee on UN Affairs and participate actively therein. 4. ADVISORY GROUP

The Advisory Group is mandated to steer the work of the IPU Committee on United Nations Affairs. It will meet on Tuesday, 8 October from 5 to 6.30 p.m. to draft the Committee's report and discuss future action.


5. LANGUAGES


