Today, 23 March 2016, the Governing Council will hold elections as outlined below.

### EXECUTIVE COMMITTEE

The Governing Council will be required to elect **two members** to replace members who are no longer parliamentarians: one member each for the African Group (end of term of office: October 2018) and the Arab Group (end of term of office: April 2017).

### COMMITTEES AND OTHER BODIES

#### Committee on the Human Rights of Parliamentarians

The Governing Council will be required to elect **one female member**.
