### TIMETABLE

The Timetable of the Assembly and related meetings is set out in **Annex 1**. The Inaugural Ceremony will take place on Saturday, 14 October at 7.30 p.m., at ExpoForum in St. Petersburg.

The Governing Council will convene on 15 and 18 October and will consider and take decisions on a host of matters relating to the functioning and activities of the IPU. The convocation of the 201<sup>st</sup> session of the IPU Governing Council is attached.

The Assembly will start its General Debate on 15 October with the high-level segment reserved for Speakers of Parliament. At its sittings on 17 and 18 October, the Assembly will adopt resolutions on the emergency item and on the subject item taken up by the Standing Committee on Democracy and Human Rights. The Assembly is expected to conclude its business by 6 p.m. on Wednesday, 18 October.

The Governor of St. Petersburg will host a reception for all heads of delegation, in the evening of 18 October at the Yusupovsky Palace.

### VENUE

There will be two sites for the St. Petersburg Assembly. Most meetings will take place at the Tavrichesky Palace. The ASGP meeting and some sittings of the Standing Committees will be held at the Parliamentary Centre. A regular shuttle (every 15 minutes) will run between the two sites to enable delegates to be at their meetings on time.

### EMERGENCY ITEM

According to Assembly Rule 11.1 and Article 14.2 of the IPU Statutes, any Member of the IPU may request the inclusion of an emergency item in the Assembly agenda. If the Assembly so decides, the emergency item will be debated by the Assembly in the morning of Monday, 16 October 2017. Provision has also been made for a drafting committee to meet in the afternoon that same day in order to prepare a draft resolution. The Assembly will then adopt a resolution on 17 October 2017.

All requests for inclusion of an emergency item must relate to a recent major situation of international concern, on which urgent action by the international community is required and on which it is appropriate for the IPU to express its opinion and mobilize a parliamentary response. All proposals for an emergency item should be accompanied by a brief explanatory memorandum and a draft resolution, which clearly define the scope of the subject covered by the request.

## STANDING COMMITTEES

All four Standing Committees will meet during the 137<sup>th</sup> IPU Assembly.

The Standing Committee on Democracy and Human Rights will discuss and adopt a resolution on the subject item *Sharing our diversity: The 20<sup>th</sup> anniversary of the Universal Declaration on Democracy*.

The other three Standing Committees will hold hearings and panel discussions on the basis of recommendations from their respective Bureaux. The draft agendas of the Standing Committees are attached.

Member Parliaments are kindly reminded that Bureau members and other IPU office-holders should be included in the national delegations to the Assembly.

## PARTICIPATION

IPU Members may appoint a maximum of eight delegates, or 10 for parliaments of countries with a population of 100 million inhabitants or more. The number of additional MPs accompanying delegations as Advisers must not exceed two.

All Member Parliaments are encouraged to strive for gender parity in the composition of their delegations. Any delegation which, for three consecutive sessions of the Assembly, is composed exclusively of parliamentarians of the same sex will automatically be reduced by one person.

Member Parliaments are also encouraged to include in their delegation young members of parliament, i.e. below 45 years of age. The IPU Forum of Young Parliamentarians will meet on 15 October 2017. Among other things, the Forum will formulate and provide input to the deliberations of the Assembly.

In addition to the Secretaries General who will attend the regular session of the Association of Secretaries General of Parliaments (ASGP), Members are encouraged to include professional parliamentary staff (IPU focal points) in their delegations, with a view to ensuring adequate support during and in follow-up to the Assembly (in particular in terms of meeting the statutory obligation by Members to prepare and disseminate reports on action undertaken on IPU decisions and resolutions).

IPU Members whose arrears equal or exceed the amount of the contributions due from them for the preceding two full years will not be represented by more than two delegates at meetings of the IPU (Article 5.2 of the Statutes), nor will they be entitled to vote.

Associate Members may participate in the Assembly and its Standing Committees with the same rights as Members, with the exception of the right to vote and to present candidates for elective office.

International organizations and other bodies invited by the Governing Council to be represented at the Assembly as Observers are reminded that they are entitled to register a maximum of two delegates.

The Plenary Hall, where the meetings of the Assembly and Governing Council will be held, has limited seating capacity. Additional seating is available in the Dumsky Hall Gallery on the first floor. The Secretariat will allocate seats for all delegations taking into account the total number of participants in the Assembly. At a minimum, each delegation of a Member Parliament will be allocated a sufficient number of seats required for a possible vote by the Assembly or Governing Council.

## STEERING COMMITTEE

The Steering Committee of the Assembly is composed of the President of the Assembly, the President of the Inter-Parliamentary Union and the Vice-President of the Executive Committee. The Presidents of the Standing Committees may take part in the work of the Steering Committee in an advisory capacity.

The Steering Committee, assisted by the IPU Secretary General, is mandated to take all appropriate measures to ensure the effective organization and smooth running of the Assembly proceedings. The first sitting of the Steering Committee is scheduled for the early morning of Sunday, 15 October 2017.

## VACANCIES TO BE FILLED DURING THE 137<sup>th</sup> ASSEMBLY

On 18 October 2017, the Governing Council will hold an election by secret ballot for the new IPU President. Candidatures, accompanied by a signed covering letter and a brief curriculum vitae, may be submitted up to Tuesday, 17 October, at 2.30 p.m. A detailed Note on the election of the IPU President is available in **Annex 2**.

A provisional list of vacancies for IPU bodies will be posted on the IPU website prior to the opening of the Assembly.

Member Parliaments, especially new Members and Members currently not holding IPU offices are encouraged to consider submitting candidatures for the main committees and bodies of the IPU (<http://www.ipu.org/strct-e/comtees.htm>). Candidates should have the expertise, as far as possible, in the areas of work of the given bodies, and should be supported by their respective parliament in carrying out their functions as IPU office-holders.

As the meeting of the Forum of Women Parliamentarians will be held on Saturday, 14 October, all geopolitical groups are urged to schedule their meetings on Friday, 13 October, or at another time which does not conflict with the meeting of the Forum of Women Parliamentarians. The Forum's draft agenda is attached.

A joint meeting of the Chairpersons of the Geopolitical Groups and Presidents of the Standing Committees will take place on Saturday, 14 October, from 11.30 a.m. to 1 p.m. The Secretaries of the Geopolitical Groups and Standing Committees are also invited to attend the meeting.

## PREPARATION OF DRAFT RESOLUTIONS AND SELECTION OF AGENDA ITEMS

The calendar pertaining to the preparation of the resolution of the Standing Committee on Democracy and Human Rights is as follows:

1-2 June 2017	Working meeting between the rapporteurs in Geneva
1 July 2017	Deadline for the rapporteurs to submit the draft resolution and explanatory memorandum to the IPU Secretariat
30 September 2017	Deadline for Member parliaments to submit proposals for amendments to the draft resolution
14-17 October 2017	Committee debates, amends and adopts the draft resolution; Co-Rapporteurs present the draft resolution and provide advice during the drafting process
18 October 2017	137 <sup>th</sup> IPU Assembly formally adopts the resolutions

All Members can contribute to the drafting of resolutions by submitting a brief written input (Article 13.1 of the Rules of the Standing Committees). The deadline for written input to the Standing Committee on Democracy and Human Rights has passed (30 April 2017). Members are encouraged to submit input for the draft resolutions to be adopted by the Standing Committee on Peace and International Security on *Sustaining peace as a vehicle for achieving sustainable development*, and by the Standing Committee on Sustainable Development, Finance and Trade at the 138<sup>th</sup> IPU Assembly (March 2018), on *Engaging the private sector in implementing the SDGs, especially on renewable energy*. Written input to these draft resolutions is welcome no later than 29 September 2017.

In accordance with the Rules of the Standing Committees, proposals for subject items to be taken up by Standing Committees should be submitted up to one day prior to the meeting of the respective Standing Committee Bureau. As such, Members wishing to do so should submit to the IPU Secretariat by 15 October 2017 at the latest their proposals for subject items to be taken up by the Standing Committee on Democracy and Human Rights.

Those proposals will serve as the basis for consultations by the respective Standing Committee Bureaux before a final decision is taken by the Standing Committee. When considering the proposals for subject items to be discussed at future Assemblies, the Bureau may recommend one of the proposals, combine two or more of them dealing with the same subject or related subjects into a single item, put forward another subject item or decide to submit more than one proposal to the Standing Committee.

### GENERAL DEBATE (Item 3 of the agenda)

The General Debate at the 137<sup>th</sup> Assembly will focus on the overall theme of *Promoting cultural pluralism and peace through inter-faith and inter-ethnic dialogue*. A concept note on this theme will be posted on the Assembly webpage in due course.

In accordance with the Assembly Rules and unless the Steering Committee decides otherwise, every delegation is entitled to eight minutes speaking time in the General Debate. When two speakers from the same delegation are registered for the Debate, the eight minutes will be shared as appropriate. By decision of the IPU Governing Council, the speaking time for Observers will be five minutes.

In light of the growing membership of the IPU (and implicitly the growing number of speakers in the General Debate), as well as of the difficulties in time management experienced at recent Assemblies, the Steering Committee may consider limiting speaking time in the General Debate (seven minutes for Members and four minutes for Observers).

Registration will take place at the speakers' registration desk, situated just outside the main entrance to the Plenary Hall (Dumsky Hall) on the ground floor of the Tavrichesky Palace. This desk will open 24 hours before the beginning of the first plenary of the Assembly, on Saturday, 14 October at 11 a.m.

Members may also send the names of their speaker(s) in advance to the IPU Secretariat by e-mail or fax, using the attached "Speakers pre-registration form" (**Annex 3**). As per established practice, the order of speakers will be determined by a public drawing of lots at 6 p.m. on Saturday, 14 October 2017 (cf. Rule 23.2 of the Rules of the Assembly).

### VICE-PRESIDENTS OF THE ASSEMBLY

According to Assembly Rule 7.3, all delegations from Member Parliaments are entitled to designate one of their members as a Vice-President of the Assembly. Some of them will be called upon to replace the President of the Assembly during a sitting or part of a sitting.

Upon arrival at the IPU Registration Desk in St. Petersburg, delegations are invited to indicate the name of the parliamentarian nominated as a Vice-President of the Assembly. Alternatively, names may be submitted to the Documents Submission and Control Service (IPU Secretariat offices, ground floor of the Tavrichesky Palace), by Saturday, 14 October 2017, at the latest.

### TABLE SHOWING THE ALLOCATION OF VOTES

A provisional table showing the votes allocated to delegations to the 137<sup>th</sup> Assembly is contained in **Annex 4**.

Member Parliaments are kindly requested to check the figures against their country name and, if necessary, inform the IPU Secretariat in Geneva in writing of any modifications required, preferably ahead of the Assembly. The final table showing the allocation of votes at the Assembly will be distributed at the opening of the session.

### LANGUAGES AND DOCUMENTATION

The IPU Secretariat will provide simultaneous interpretation in the IPU Assembly's working languages (Arabic, English, French and Spanish) at the meetings of all statutory bodies.

Four other interpretation channels have been reserved for Chinese, Japanese, Portuguese and Russian at sittings of the Assembly and the Governing Council, and for some sittings of the Standing Committees. These booths are provided free of charge and may be used by the interpretation teams for these languages.

Delegates may, exceptionally, use another language provided that they arrange for their speech to be interpreted into one of the IPU's official languages (English and French) by a person designated by them, who will be given access to an interpretation booth. To allow for all necessary arrangements to be made in good time, delegations should contact well in advance the Chief Interpreter (Ms. F. Steinig-Huang) or the English booth interpreters assigned to the meeting at which the speech will be delivered. Moreover, eight copies of the translation of the speech into one of the IPU's official languages should be given to the Chief Interpreter or to the English booth for distribution to the other interpreters.

Electronic copies of speeches should be e-mailed in PDF format to [speeches@ipu.org](mailto:speeches@ipu.org), **a minimum of three hours before the speech is to be made**, so as to also ensure a high quality of simultaneous interpretation into the other working languages

The texts of official statements delivered in the General Debate will be published on the Assembly webpage and will be part of the records of the Assembly. Due to technical limitations, only speeches in English, French and Spanish will be posted.

Documentation pertaining to the work of the Assembly, Governing Council, Standing Committees and other IPU bodies, as well as other events taking place during the 137<sup>th</sup> Assembly, will be available on the IPU website at: [www.ipu.org/conf-e/137agnd.htm](http://www.ipu.org/conf-e/137agnd.htm), as well as on the Assembly App.

In keeping with the decision by the IPU Governing Bodies to reduce the carbon footprint of the Organization and continue to curb paper waste, only a limited number of documentation sets will be printed for the various sittings of the Assembly.

### ASSEMBLY APP

The 137<sup>th</sup> Assembly App will be available for downloading free of charge, in early September 2017.

An App Help Desk will be available at the Assembly venue. The Desk will assist delegates in downloading and using the App. It is located close to the Ekaterininsky Hall on the ground floor of the Tavrichesky Palace and will be open from 9 a.m. to 6.30 p.m. from 13 to 18 October 2017.

A short users' manual in English and French will be posted on the website and distributed, upon request, at the Registration and Information Desk.

The App is intended to allow the online consultation of official IPU documents as part of the IPU's paper smart policy and to facilitate delegates' participation in IPU Assemblies.

## Election of the President of the Inter-Parliamentary Union

The President of the Inter-Parliamentary Union is the political head of the organization. The President chairs the Governing Council and the Executive Committee. The Council elects him or her for a mandate of three years at the second Assembly of the year. According to the IPU Statutes and Rules, *"the retiring President shall not be eligible for re-election for three years and shall be replaced by a person belonging to another Parliament. An endeavor will be made to ensure a regular rotation between the different geopolitical groups"*.

The provisions relating to the President are contained in Article 19 of the IPU Statutes and Rules 6 to 11 of the Council Rules. They are supplemented by practice as it has evolved over the years.

The principle of regional rotation is generally observed. Over the past twenty years, the Presidency of the IPU has been ensured by prominent MPs from Egypt (Arab Group, 1994-1997), Spain (Twelve Plus Group, 1997-1999), India (Asia-Pacific Group, 1999-2002), Chile (Group of Latin America and the Caribbean, 2002-2005), Italy (Twelve Plus Group, 2005-2008), Namibia (African Group, 2008-2011), Morocco (Arab Group, 2011-2014) and Bangladesh (Asia-Pacific Group, 2014-2017).<sup>1</sup>

There are no formal criteria for the election of the IPU President, other than the fact that he/she is a sitting Member of Parliament expecting to remain an MP for the duration of the term of IPU President (in this case, 2017-2020). Historically, IPU Presidents have been outstanding political leaders, well respected nationally and internationally, firmly committed to the core IPU values and principles – in particular the promotion of democracy, human rights and the rule of law – and able to invest significant time and energy in effectively carrying out the high office of IPU President.

As the IPU is playing an increasingly important role in political dialogue and understanding within and among nations, the IPU President is expected to be a mediator and bridge-builder, exercising tact, credibility and respect for the IPU membership in all its diversity. He/she is called upon to regularly interact with Heads of State and Government, Speakers of Parliament, the UN Secretary-General and other high-level officials. He/she should ideally have a good command of at least one of the official languages of the IPU: English and French. As a gender-sensitive organization, the IPU also attaches great importance to gender equality and the political empowerment of women at all levels.

The election of the IPU President is announced formally in the convocation of the Council session at which the election will take place. It shall be communicated at least four months before the opening of the regular session of the Council (in this case, in mid-June 2017).

Worthy candidates are expected to express their interest in running for the position of IPU President through a formal letter addressed to the IPU Secretary General. The letter should underscore the key skills and competencies of the candidate and their vision of promoting the strategic plan of the IPU, and it should be accompanied by a brief CV. Candidatures may be submitted by the candidate directly, by a member Parliament or group of Parliaments, or by one or more Geopolitical Groups. There is no formal deadline for the submission of candidatures, although in practice it is important that these are submitted in good time, so as to allow for translation and distribution.

While not a formal requirement, in practice it is expected that the candidates for the post of President can count upon the financial and material support of their respective Parliament in the exercise of the IPU Presidency.

The candidates will present themselves to the IPU membership on the occasion of the 137<sup>th</sup> IPU Assembly, to be held in St. Petersburg, Russian Federation, on 14-18 October 2017. As per usual practice, they will be invited for hearings by the Geopolitical Groups, the Forum of Women Parliamentarians and the Forum of Young Parliamentarians of the IPU.

The election of the President takes place at the last sitting of the Council. Voting shall be conducted by secret ballot. Three delegates from each Member Parliament can cast a vote, provided that both genders are represented among them; if not, only two delegates can vote. This year, the vote will take place on 18 October.

The candidate who obtains an absolute majority of the votes cast shall be elected President. If no candidate obtains this majority during the first round of voting, the candidate who has received the least number of votes will be eliminated, and additional rounds will take place until one of the candidates obtains an absolute majority.

In preparation for that, the Committee will hold an expert hearing to share opinions with members about how both concepts have evolved and where the challenges and opportunities lie. There will also be a discussion about the measures and actions parliaments can envisage in terms of legislation, policy development, evaluation and oversight. The co-Rapporteurs will draw on the hearing and the subsequent debate in preparing the first draft of the resolution.

5. **Panel discussion on the implementation of a previous resolution on cyber warfare (Hanoi, 2015)**

In 2015 the IPU adopted a resolution entitled *Cyber warfare: a serious threat to peace and global security*. After two years, the Committee will hold a discussion on the implementation of this resolution by IPU Members. The discussion will also include a briefing on how to engage more actively in conflict prevention in cyberspace and ensure that cyberspace is used "for peaceful purposes" and "in the interests of all countries".

6. **Panel discussion on *The role of parliament in monitoring the action of national armed forces participating in UN peacekeeping operations***

The panel discussion will afford the Committee an opportunity to exchange views about challenges to implementing parliamentary monitoring and oversight of the actions of national armed forces participating in UN peacekeeping operations. Such actions are aimed at enforcing the democratic legitimacy of humanitarian interventions and peacekeeping missions.

The Committee will fill the existing vacancies on the Bureau, based on proposals from the geopolitical groups.

4. **Parliamentary contribution to the 2017 UN Climate Change Conference**

On 12 November, a Parliamentary Meeting co-organized by the IPU, the Parliament of Fiji and the German Bundestag will take on the occasion of COP23 in Bonn. The Committee will be briefed on practical arrangements for the Meeting. Committee members will also exchange views on a draft outcome document.

5. **Debate on *Engaging the private sector in implementing the SDGs, especially on renewable energy***

This debate will be organized around the theme of the Committee resolution, which is expected to be adopted at the 138<sup>th</sup> Assembly in Geneva. The debate will provide the Committee with an opportunity to exchange views on effective ways to engage the private sector in SDG implementation. Special emphasis will be placed on renewable energy as a sustainable, reliable, resilient and affordable way to ensure universal access to energy and fight climate change. The debate will also provide the co-Rapporteurs with initial information about how IPU Member Parliaments approach this issue.

6. **Panel discussion on *Using science and research to achieve the highest health standards***

Without scientific knowledge, it is hard to have public health legislation and policy that makes sense. However, it is increasingly recognized that the development of evidence-informed health policy is not only a technical problem of knowledge exchange or translation, but is also a political challenge. The panel will discuss ways in which parliaments can bridge this gap and ensure that health laws and policies, and their implementation, are continuously informed by robust scientific findings.

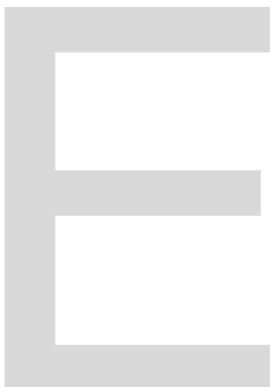

## Draft agenda

As the principal deliberative and policy-making body of the United Nations, the General Assembly lies at the centre of the system of global governance. It has been defined a "parliament of nations" in which each country participates on an equal footing. Yet, the General Assembly is often seen as less relevant in the management of world affairs than the Security Council or of other, less representative bodies such as the G20. This panel will review recent reforms aimed at strengthening the authority of the General Assembly consistent with the vision of the UN Charter. Among other things, it will look into the modalities of work of the General Assembly, the role of the President of the General Assembly, as well as the legal weight of General Assembly resolutions and decisions. 4. **Panel discussion: *The parliamentary dimension to the United Nations – 20 years in the making***

As trade, finance, and national economies as a whole become more globalized than ever, and as issues such as climate change and poverty underscore the importance of international cooperation, the system of international governance managed by the United Nations and related organizations (World Trade Organization, World Bank etc.) has had to adjust, seeking ways to become more open and accountable.

As the world organization of national parliaments, the IPU has led the way in bringing the peoples' representatives closer to the decision-making processes of the United Nations. The idea underlying this is that international affairs are no longer the exclusive domain of the executive branch, in that involving parliaments in global talks and in the UN decision-making process will help strengthen democratic participation at the global level while facilitating implementation of international commitments within countries. Over the past twenty years, the role of national parliaments in international relations, filling the so-called "democracy gap", has gained strong recognition at the United Nations. This session will take stock of the progress made in, and current challenges to building the parliamentary dimension to the United Nations in the lead up to a new resolution of the General Assembly on *interaction between the United Nations, national parliaments and the IPU* due in spring 2018. #### **4. Contributing to the work of the 137<sup>th</sup> Assembly from a gender perspective**

Participants will be invited to discuss the following item on the agenda of the 137<sup>th</sup> Assembly:

- Sharing our diversity: The 20<sup>th</sup> anniversary of the Universal Declaration on Democracy (*Standing Committee on Democracy and Human Rights*)

Participants will split into two groups to discuss the following sub-themes:

**Group 1:** How can technology be at the service of democracy and gender equality?  
Challenges and opportunities

The participants will be invited to discuss how to ensure that the whole population can enjoy the benefits that the Internet can bring to economic, social, cultural and environmental life. They will also share good practices developed to protect both freedom of speech and the right to physical and psychological integrity. They will discuss in particular means to stop online harassment and cyber-violence that targets women and girls as well as measures to combat trafficking in persons perpetrated through the Internet. The participants will also be invited to identify means and strategies to promote and increase the public participation of women and girls by using online means and tools.

**Group 2:** Educating for democracy and gender equality at all steps of the ladder: family, community and State

The participants will be invited to discuss how democratic values and principles can be furthered from generation to generation, focusing in particular on gender equality values and practices. They will share good practices experienced in education programmes on democracy in school curricula. They will also identify ways to anchor democratic and gender equality principles and values in family education. They will discuss in particular how to promote participation and empowerment in the learning experience of girls.

On the recommendation of its Bureau, the Forum will designate a chairperson and a rapporteur for each group. They will agree on recommendations that the rapporteurs will submit to the Forum of Women Parliamentarians at its afternoon sitting.

#### **5. Panel discussion Marking the fifth anniversary of the Plan of Action for Gender-sensitive Parliaments**

A gender-sensitive parliament is one that responds to the needs and interests of both men and women in its structures, operations, methods and work. It is a parliament that embodies gender equality and that delivers on it.

The Plan of Action for Gender-sensitive parliaments was adopted by IPU Members at the 127<sup>th</sup> Assembly in Quebec, in 2012. As a tool to support parliaments in taking action to become more gender-sensitive institutions, the Plan of Action proposed concrete solutions to situations common to all countries while offering a wide range of options responding to individual situations.

Five years after the adoption of the Plan of Action, many parliaments have adopted measures to further equal representation of men and women on parliamentary committees membership, to open day care centers for members and staff's children or to enhance capacities to better address gender equality issues.

What has your Parliament done?

Participants in the Panel discussion are invited to share information on and lessons learned from advancements made and challenges encountered by their parliaments to enhance their gender sensitivity and their ability to deliver on gender equality.

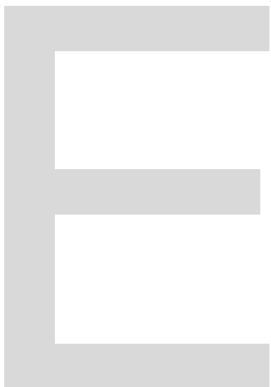
