### **Session III. General effects of climate change**

This session will review the impacts of climate change, such as climate migration and health effects, and their management. It will also consider the role of health in the global development strategy until 2030.

It will examine developments since the adoption of the Paris Agreement on Climate Change and discuss legislative gaps that need to be bridged for its successful implementation. Participants will be invited to report on the status of implementation in their respective countries. The session will focus on opportunities for parliamentarians to address key economic, social and environmental issues, such as environmental protection, support to the local green economy, reinforcement of social cohesion and participation of citizens.

### **IV: Water as key enabler of sustainable development and promoting effective water governance in the region: Key steps for parliaments**

As specified in the 2015 IPU Resolution *Shaping water governance: Promoting parliamentary action on water and sanitation*, water governance can be a key element in maintaining peace between States and can promote cooperation. The Resolution also specifies that effective management and multilevel good governance of water resources are indispensable preconditions for achieving the human right to water. The session will discuss ways in which water governance can support achievement of the SDGs. The discussion will also be informed by the outcome of the 2016 Budapest Water Summit.

Strong political will and leadership are key to promoting effective water governance nationally and across borders. This session will hear some examples of how countries of the region have managed to create legislative frameworks to enable effective water governance and transboundary cooperation on water issues. Special emphasis will be given to effective strategies to balance competing human needs while giving priority to water for personal and domestic use for all, without discrimination, with a particular focus on gender equality and the most vulnerable sectors of society. Based on these examples, the session will aim to identify key steps for parliaments to take to further support these efforts.
