



## Translating international human rights commitments into national realities: The contribution of parliaments to the work of the United Nations Human Rights Council

Seminar for African parliaments organized jointly by the Parliament of the Kingdom of Morocco and the Inter-Parliamentary Union, in partnership with the Inter-ministerial delegation for human rights of Morocco, the National Council of Human Rights of Morocco, and in collaboration with the Office of the United Nations High Commissioner for Human Rights

**29-30 September 2014, Parliament of the Kingdom of Morocco (Rabat)**

### GENERAL INFORMATION

#### 1. BACKGROUND AND PURPOSE OF THE SEMINAR

Parliaments and the United Nations Human Rights Council are natural partners. Without parliamentary action - be it passing laws or overseeing government action - very few recommendations of the Universal Periodic Review (UPR), the mechanism through which the Council examines the human rights situation in all UN Member States, could actually be implemented. Indeed, the mandate entrusted to parliaments to legislate and oversee government action in terms of holding the executive to account for their actions is crucial to the work of the Human Rights Council.

In recent years, the Inter-Parliamentary Union has made it a priority to raise awareness among parliaments about the Council and its UPR and the contribution they can make to them. The IPU systematically informs parliaments of the forthcoming examination of their countries' national reports. The IPU organizes capacity-building workshops for parliamentarians to enhance their understanding of the UPR and their role. A recent survey conducted by the IPU found that many parliaments are still unfamiliar with the work of the Council or its UPR. The tide is turning, however, and parliaments are increasingly taking an active interest in the work of the Council.

On 29 May 2013, the Human Rights Council, with the support of the Office of the United Nations High Commissioner for Human Rights (OHCHR) and the IPU, held a panel discussion in Geneva on the contribution of parliaments to promoting human rights at the national level and to the work of the Council. The participants concurred that parliaments had a critical part to play in ensuring respect for human rights domestically and that parliaments and the Human Rights Council stood to gain much from closer cooperation. To this end, participants formulated the following recommendations:

- Further enhance awareness among members of parliaments of the existence of the Human Rights Council and its UPR and the need for their full involvement in its work;
- Foster greater involvement of members of parliament in the three different reporting stages of the UPR; and
- Promote the adoption, by the Human Rights Council, of practical steps to engage with parliaments and to take their work into account.

On 27 June 2014, during its 26<sup>th</sup> session, the Human Rights Council adopted a resolution<sup>1</sup> endorsing the need to involve parliaments in its work and to benefit from their contribution to the promotion of human rights.

The regional seminar in Rabat aims to inform participants about how the Human Rights Council functions and alert them to the importance of becoming more involved. The meeting aims to identify good parliamentary practices in working with the Council and in promoting and protecting human rights in general, in particular, by initiating an effective and continuous dialogue with other stakeholders such as national institutions and civil society.

The main objectives of the regional seminar in Rabat are as follows:

- Inform parliamentarians of the functioning of the Human Rights Council and its Universal Periodic Review and sensitize them to becoming involved as guardians of human rights in order to better promote the mechanism;
- Highlight the role to be played by parliaments in the protection of human rights at the national level;
- Reflect on the framework, best practices and parliamentary support strategies in the work of the HRC with the support of the IPU;
- Exchange good parliamentary practices in the involvement of parliamentarians in UNHRC sessions and the UPR process;
- Determine the appropriate cooperation framework among other stakeholders, in particular the executive, national human rights institutions, civil society and parliaments with a view to maximizing the latter's contribution to the promotion of human rights.

## 2. VENUE AND DATE

The seminar will be held on 29 and 30 September 2014 at the Parliament of the Kingdom of Morocco.

## 3. INVITED PARLIAMENTARIANS

This seminar is open to parliaments from Africa in order to benefit from their experiences (see list of invited countries)<sup>2</sup>. Representatives of national human rights institutions, Moroccan and African civil society as well as international organizations present in Morocco are also invited to the seminar.
