Over recent years, the World Trade Organization (WTO) has established a tradition of holding annual public events where participants from government, parliament, civil society, the business sector, academia and the media jointly reflect upon the functioning of the multilateral trading system and analyse the state of advancement of the Doha Development Agenda. The annual **WTO Public Forum** is now a prominent feature of the international calendar.

It has likewise become a tradition to hold a special Parliamentary session during the WTO Public Forum. Such sessions are geared towards the specific interests of members of parliament specializing in international trade, and are closely linked with the process known as the *Parliamentary Conference on the WTO*, which is driven by the synergies of the IPU and the European Parliament, and constitutes a de facto parliamentary dimension of this inter-governmental organization.

This year's WTO Public Forum will be held from 26 to 28 September, on the WTO premises in Geneva (Centre William Rappard), under the overall theme ***Trade: Behind the Headlines***. The Parliamentary session will be held on **Tuesday, 26 September 2017, from 11:30 a.m. to 1 p.m. in Room W at WTO Headquarters.**

The theme of the Parliamentary session is ***Making trade fair: The contribution of parliaments***. Global trade openness has boosted economic growth and competitiveness. It has also enabled poorer countries to catch up and become part of the global trading system. Over the last years, it has however been evident that not everybody benefits equally from these opportunities, and many people feel left behind, which has in turn stirred up feelings of widespread anxiety and frustration, along with serious questions about the relevance of the global trading system. This has been particularly evident in several election campaigns, not the least in the developed world, and has sparked a new debate on the rules of global trade and the need to make sure that trade is fair and sustainable. The objective of this session is to afford parliamentarians the opportunity to reflect upon their role in this debate and to put forward concrete proposals for parliamentary action and in support of initiatives on how the benefits of trade can be more equally shared and can contribute to more sustainable trade in line with the Sustainable Development Goals.

The 26 September parliamentary session is open to all duly accredited Forum participants. The WTO Secretariat will provide interpretation in English, French and Spanish. A detailed programme of the session will be posted shortly on the IPU website: <http://www.ipu.org/splz-e/wto-forum17.htm>.
